Provisional affiliation was granted to the Self financing programmes in BCom with Computer Application (40), BCom with Finance (40), BCom with Co-operation (40), BBA (30), BSc Mathematics(24), BA English(24) & BCA (24) during the academic year 2015-16 at MET's College of Advanced Studies, Kuruvilassery P.O, Mala, Thrissur, vide University Order read as first above.

2. Continuation of Provisional Affiliation was granted to the abovementioned self financing programmes for the academic year 2019-20, vide University Order read as second above.
3. Vide paper read as third above, the Principal, MET's College of Advanced Studies, Kuruvilassery P.O, Mala, Thrissur, has requested to grant continuation of provisional affiliation to the existing self financing programmes for the academic year 2020-21 and has remitted ₹1,40,000/- (Rupees one lakh forty thousand only) towards affiliation fee vide chalan No.192245056 dated 18.12.2019 by e-payment.
4. The Principal has also submitted renewal of NOC from the Government for conducting the abovementioned self financing programmes for the academic years up to 2020-21 vide paper read as fourth above.
5. Considering the above, sanction has been accorded by the Vice-Chancellor on 09.02.2020, to grant Continuation of Provisional affiliation to the abovementioned self financing programmes for the academic year 2020-21 at MET's College of Advanced Studies, Kuruvilassery , Mala, Thrissur.

7. The Principal shall strictly follow the Syllabi approved in the University website (www. uoc.ac.in) for selecting complementary courses.
 8. Selection and admission shall be made only on the basis of the rules and regulations of the University/Government and on the directions issued by the University/Government from time to time.
 9. In the light of the directions of the Supreme Court of India in WP(C) 656/1998, the institutions shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent such instances appropriate action including withdrawal of affiliation of the college will be initiated.
 10. The conduct of University examinations of any sort including that of SDE examinations is compulsory and binding on all colleges affiliated to the University of Calicut.
 11. A list of colleges which have renewed their provisional affiliation will be forwarded to the Office of the Controller of Examinations to ensure that examinations are not conducted in those colleges which do not have valid affiliation order.
 12. Affiliation granted is strictly provisional and only for the academic year 2020-21. The college has to apply for continuation of provisional affiliation for the ensuing years, remitting the fee fixed by the University. Admission to the next academic year shall be made only after obtaining prior permission from the University.
 13. Principal shall strictly follow the approved syllabus, which is available in the University website, for selecting complementary courses.
 14. The complementary courses/common courses are based on the details of registration of candidates for examination and shall not be treated as a factor for calculating the work load for the subject/ for the requirement of teaching faculty, for which competent orders shall be obtained from the Govt/University.
