ORDER

Provisional affiliation was granted to the Self financing programmes in BCom Computer Application (40), BCom Finance (40), BCom Co-operation (40), Bachelor of Business Administration -BBA (30), BSc Mathematics (24), BA English Language & Literature (24) and BCA (24) during the academic year 2015-16 at MET's College of Advanced Studies, Kuruvilassery P.O, Mala, Thrissur, vide University Order read as first above.

- 2. Provisional Affiliation was granted to the self financing programme MCom Finance for the academic year 2020-21 vide University Order read as second above.
- 3. Continuation of Provisional Affiliation was granted to the above mentioned self financing programmes for the academic year 2021-22 vide University Order read as third and fourth above.
- 4. The programmes BA English Language & Literature(24) & BSc Mathematics(24) were disaffiliated w.e.from 2022-23 with a direction to take Continuation of Provisional Affiliation for the existing batch vide University Order read as fifth above.
- 5. Vide paper read as sixth above, the Principal, MET's College of Advanced Studies, Kuruvilassery P.O, Mala, Thrissur, has requested to grant continuation of provisional affiliation to the existing self financing programmes for the academic year 2022-23 and has remitted ₹1,45,000/- (Rupees one lakh forty five thousand only) towards affiliation fee vide chalan No.212596463 dated 20.12.2021 by e-payment.
- 6. The Principal has also submitted renewal of NOC from the Government for conducting the above mentioned self financing programmes for the academic years 2022-23 vide paper read as seventh above.
- 7. Considering the above, sanction has been accorded by the Vice-Chancellor on 03.10.2022, to grant Continuation of Provisional affiliation to the above mentioned self financing programmes with strict direction to <u>Principal to engage faculties having required qualification as per the UGC regulations and in compliance to the provisions under Act 13 of 2021 Kerala self financing college teaching and non teaching employees (appointment and conditions of services) for the academic year 2022-23 at MET's College of Advanced Studies, Kuruvilassery, Mala, Thrissur.</u>

- 9. The Principal shall strictly follow the Syllabi approved in the University website (www. uoc.ac.in) for selecting complementary courses.
- 10. Selection and admission shall be made only on the basis of the rules and regulations of the University/Government and on the directions issued by the University/Government from time to time.
- 11. In the light of the directions of the Supreme Court of India in WP(C) 656/1998, the institutions shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent such instances appropriate action including withdrawal of affiliation of the college will be initiated.
- 12. The conduct of University examinations of any sort including that of SDE examinations is compulsory and binding on all colleges affiliated to the University of Calicut.
- 13. The Office of the Controller of Examinations shall ensure that examinations are not conducted in those colleges which do not have valid affiliation order.
- 14. Affiliation granted is strictly provisional and only for the academic year 2022-23. The college has to apply for continuation of provisional affiliation for the ensuing years, remitting the fee fixed by the University. Admission to the next academic year shall be made only after obtaining prior permission from the University.
- 15. The complementary courses/common courses are based on the details of registration of candidates for examination and shall not be treated as a factor for calculating the work load for the subject/ for the requirement of teaching faculty, for which competent orders shall be obtained from the Govt/University.
- 16. The Principal is directed to engage faculties having required qualfication as per the UGC regulations and in compliance to the provisions under Act 13 of 2021 Kerala self financing college teaching and non teaching employees (appointment and conditions of services).
