Provisional Affiliation also granted to the self financing programme MCom Finance(12) for the academic year 2020-21 vide University Order read as second.

- 2. The programmes, BA English Language & Literature(24) and BSc Mathematics(24) were disaffiliated w.e.from 2022-23 with a direction to take Continuation of Provisional Affiliation to the programmes till the completion of the existing batch, vide University Order read as third.
- 3. Continuation of Provisional Affiliation for the academic year 2022-23 for the above mentioned programmes was granted vide University Order read as fourth.
- 4. MCom Finance(12) programme disaffiliated w.e.from the academic year 2023-24 vide University Order read as fifth.
- 5. Provisional Affiliation granted to BSc Artificial Intelligence(24) programme for the AY 2022-23 with permission to commence classes during 2023-24 vide University Order read as sixth.
- 6. Intake of BCA programme enhanced from 24 to 36 vide University Order read as seventh
- 7. Vide paper read as eighth, the Principal has requested to grant continuation of provisional affiliation to the existing self financing programmes for the academic year 2023-24 by remitting ₹1,40,000/- (Rupees one lakh forty thousand only) towards affiliation fee vide challan Nos 222831855 dated 19.12.2022 and 231033112 dated 18.01.2023.  - Affiliation granted is strictly provisional and only for the academic year 2023-24.
 - The conduct of University Examinations of any sort including that of SDE Examinations is compulsory and binding on all colleges affiliated to the University of Calicut.
 - Admission to the next academic year shall be made only after obtaining prior permission from the University.
