<u>ORDER</u>

Provisional affiliation was granted to the Self financing programme BSc Artificial Intelligence (24) for the academic year 2022-23 with permission to commence classes in 2023-24 at MET's College of Advanced Studies, Kuruvilassery P.O, Mala, Thrissur, vide University Order read as first.

2. The Principal, vide the paper read as second has requested to grant Continuation of Provisional Affiliation to the existing programmes for the academic year 2024-25.

3. Accordingly, Continuation of Provisional affiliation was granted for 2024-25 conditionally subject to the submission of renewed NOC vide University Order read as third and an Inspection Commission was appointed for verifying the instructional and infrastructural facilities available at the college for considering CPA to BSc Artificial Intelligence, vide University Order read as fourth.

4. The Commission after inspection submitted the report recommending CPA.

5. The Principal has also submitted renewed NOC.(ref 5)

6. Considering the above, sanction has been accorded by the Vice Chancellor to

(i) make the University Order read as third absolute and:

(ii) grant Continuation of Provisional Affiliation to the following self financing programme for the academic year 2024-25 at MET's College of Advanced Studies, Kuruvilassery P.O, Mala, Thrissur with strict direction to the Principal to engage faculties having required qualification as per the UGC regulations and in compliance with the provisions under Act 13 of 2021 Kerala self financing college teaching and non teaching (appointment and conditions of services).

7. Orders are issued accordingly with the following terms and conditions.

• The Principal shall strictly follow the syllabi available in the University website www.uoc.ac.in for

selecting complementary courses.

- The complementary courses/common courses specified in this order are based on the details of registration of candidates for examination and shall not be treated as a factor for calculating the work load for the subject/for the requirement of teaching faculty, for which competent orders shall be obtained from the Govt/University.
- Selection and admission shall be made only on the basis of the rules and regulations of the University/Government and on the basis of the directions issued by the University/Government from time to time.
- In the light of the directions of the Supreme Court of India in WP (C) 656/1998, the institution shall take stringent measures for prevention of ragging in any form.
- Affiliation granted is strictly provisional and only for the academic year 2024-25. The college has to apply for CPA for the ensuing years remitting the fee fixed by the University, along with the extension of approval orders, if any, from the apex bodies concerned.
- The Office of Controller of Examinations shall ensure that examinations are not conducted in those colleges which do not have valid continuation of provisional affiliation orders.
- The conduct of University Examinations of any sort including that of the SDE Examinations is compulsory and binding on all colleges affiliated to the University of Calicut.
- The college is liable to comply with the general conditions stipulated in the renewed NOC from the Govt. of Kerala for the academic year 2024-25.
- Admission to the next academic year shall be made only after obtaining prior permission from the University.
- Violation of any of the above will lead to the cancellation of affiliation.
