2. BA English Language & Literature(24) and BSc Mathematics(24) programmes were disaffiliated w.e.from 2022-23 and MCom Finance(12) programme disaffiliated w.e.from the academic year 2023-24 vide University Order read as first and second.

3. Permanent increase of Intake-was granted to BCA programme from 24 to 36 vide University Order read as third.

4. Continuation of Provisional Affiliation was granted to the above mentioned programmes for the academic year 2023-24 vide University Order read as fourth.

5. The Principal, vide paper read as fifth, has requested to grant continuation of provisional affiliation to the existing self financing programmes for the academic year 2024-25 with details of application forwarded to Higher Education Dept. for renewal of NOC for 2024-25.

Considering the matter in detail, the Vice Chancellor has accorded sanction to grant Continuation of Provisional Affiliation to the self financing programmes, as detailed below at MET's College of Advanced Studies, Kuruvilassery, Mala, Thrissur, for 2024-25 on conditional basis subject to the submission of renewal of NOC from Higher Education Department with directions to strict adherence to qualifications prescribed by the UGC and in compliance to the provisions under Act 13 of 2021 Kerala self financing college teaching and non teaching employees (appointment and conditions of services) in the recruitment of faculties.

7. Orders are issued accordingly with the following terms and conditions.

- The Principal shall strictly follow the syllabi available in the University website www.uoc.ac.in for selecting complementary courses.
- The complementary courses/common courses specified in this order are based on the details of registration of candidates for examination and shall not be treated as a factor for calculating the work load for the subject/for the requirement of teaching faculty, for which competent orders shall be obtained from the Govt/University.
- Selection and admission shall be made only on the basis of the rules and regulations of the University/Government and on the basis of the directions issued by the University/Government from time to time.
- In the light of the directions of the Supreme Court of India in WP (C) 656/1998, the institution shall take stringent measures for prevention of ragging in any form.
- Affiliation granted is strictly provisional and only for the academic year 2024-25. The college has to apply for CPA for the ensuing years remitting the fee fixed by the University, along with the extension of approval orders, if any, from the apex bodies concerned.
- The Office of Controller of Examinations shall ensure that examinations are not conducted in those colleges which do not have valid continuation of provisional affiliation orders.
- The conduct of University Examinations of any sort including that of the SDE Examinations is compulsory and binding on all colleges affiliated to the University of Calicut.
- The college is liable to comply with the general conditions stipulated in the renewed NOC from the Govt. of Kerala for the academic year 2024-25.
- Admission to the next academic year shall be made only after obtaining prior permission from the University.
- Violation of any of the above will lead to the cancellation of affiliation.

ORDER

1. The principals of various Colleges had submitted applications for additional affiliation of programmes vide paper read as (1).
2. After completing all the statutory procedures, including inspection by the District Level Inspection Commissions constituted for the purpose and after consideration by the Syndicate, eligible programmes were recommended to Government, vide papers read from second to fourth, for obtaining views, as stipulated in Calicut University First Statutes, 1977.
3. The Government of Kerala accorded Administrative Sanction, vide reference cited fifth to sixth, and issued No Objection Certificate, vide G.O cited seventh to tenth, for starting new self-financing programmes for the academic year 2024-25, subject to the terms and conditions specified in the said G.Os.
4. On receipt of Administrative Sanction and No Objection Certificates from Government, the Principals of the following Colleges have submitted requests for affiliation to the programmes, along with affidavit in the prescribed format and challan receipts towards payment of fee.
5. The meeting of the Syndicate held on 31.08.2024, considered the matter, vide Item No.2024.1007* and resolved to approve the matter.
6. The Vice Chancellor has accorded sanction to implement the resolution of the Syndicate to grant provisional affiliation to the FYUG programme, as detailed below for the academic year 2024-25:

8. Orders are issued accordingly subject to the following terms and conditions:

- Affiliation granted is strictly provisional and only for the academic year 2024-25.
- The college has to apply for Continuation of Provisional Affiliation for the ensuing academic year remitting the fee fixed by the University.
- **Provisional affiliation granted for BBA/BCA programmes is subject to the approval of the AICTE. The Principals of the colleges shall ensure that AICTE approval for BBA/BCA programmes is received.**
- The Educational agency/college shall abide by the conditions stipulated in the No Objection Certificate issued by the Government with regard to the procedure of admission, collection of fees and other regulations.
- Admission to the next academic year shall be made only after obtaining prior permission from the University.

- Conduct of University Examinations of any sort, including that of SDE is compulsory and binding on all colleges affiliated to the University of Calicut.
- The Principal shall follow the approved syllabus of the University.
- In the light of directions of Supreme Court of India in WP(C) No. 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent such instances of ragging, the affiliation granted to the college will automatically be cancelled.
- Violation of the above may lead to cancellation of affiliation.
