ORDER

1. Principals of various Colleges affiliated to University of Calicut had submitted applications in prescribed format, remitting required registration fee for additional affiliation of programmes in the colleges for academic years 2022-23 & 2023-24. After completing all the statutory procedures, including inspection by District Level Inspection Commissions constituted for the purpose and after consideration by the Syndicate, eligible programmes were recommended to Government, vide paper read as second, for obtaining views, as stipulated in Calicut University First Statutes, 1977.
2. Government of Kerala accorded Administrative Sanction vide reference cited third, for starting new self-financing programmes as recommended by the University and with a direction to the managements of colleges for executing agreement with Government as per the conditions stipulated therein.
3. Government of Kerala have issued No Objection Certificates vide Government Orders cited fourth, fifth & sixth for starting new self-financing programmes in various Arts & Science Colleges affiliated to University of Calicut for academic years 2022-23 and 2023-24, subject to terms and conditions specified in aforementioned G.Os.
4. On receipt of administrative sanction and no objection certificates from Government, Principals of following Colleges have submitted requests for affiliation to the programmes, along with affidavits in prescribed format and in stamp paper worth ₹.200/- and challan receipts towards remittance of affiliation fee @ ₹.20,000/- (Rupees Twenty thousand only) for UG programmes and ₹.25,000/- (Rupees Twenty five thousand only) for PG programmes, for academic year 2022-23. Also, certain colleges have requested for commencing classes during academic year 2023-24.
5. As per orders of Vice Chancellor, the matter of granting provisional affiliation to additional programmes for academic year 2022-23 and granting permission to start classes during academic year 2023-24 based on requests of colleges concerned, was placed before the Syndicate. Meeting of the Syndicate held on 13.12.2022 had considered the matter vide Item No.2022.1313* and Item No.2022.1397* and resolved to approve the matter.

6. Sanction was accorded by the Vice Chancellor to implement the aforesaid resolutions of the Syndicate

7. Following orders are, therefore, issued.

(i) Provisional Affiliation is granted to new programmes under self-financing stream in Arts & Science Colleges affiliated to University of Calicut for the academic year 2022-23, as shown below.

ii. The aforementioned colleges, except Sree Narayana Guru College of Advanced Studies, Chelannur, Kozhikode, are permitted to commence classes of newly sanctioned programmes during the academic year 2023-24.

iii. Admission to M.A. English Language & Literature programme in Sree Narayana Guru College of Advanced Studies, Chelannur, Kozhikode for the academic year 2022-23 shall be made strictly as per the schedule prescribed below and the college shall follow the directions regarding procedure of admission and other statutory obligations.

iv. Classes shall be commenced on the seventh working day after press release. Since the first semester examination will be conducted together with other students after completion of the lessons, the College should ensure that the students who are admitted in the aforementioned programme, have attained adequate attendance and complete the lessons in stipulated time frame and conduct extra classes during holidays including mid-summer vacation to compensate for academic days' loss.

8. Provisional affiliation granted is subject to the following terms and conditions:

- Affiliation granted is strictly provisional and only for the academic year 2022-23. Colleges have to apply for Continuation of Provisional Affiliation for the ensuing academic year by remitting fee fixed by the University.
- Educational agency/college shall abide by the conditions stipulated in No Objection Certificates issued by Government with regard to procedure of admission, collection of fees and other regulations, failing which affiliation granted will automatically be cancelled.
- Admission to the next academic year shall be made only after obtaining prior permission from the University.
- Conduct of University Examinations of any sort including that of SDE Examinations is compulsory and binding on all colleges affiliated to University of Calicut.

- In the light of directions of Supreme Court of India in WP(C) No. 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent such instances, appropriate action including withdrawal of affiliation of the college will be initiated.

9. The Controller of Examinations shall ensure that examinations are not conducted in those colleges which do not have valid affiliation orders.

10. Resolutions of the Syndicate cited seventh are thus implemented.
